EFFICIENCY OF THE DRUG FREE VILLAGE (VILLAGE PROGRAM SHINES IN THE CITY OF SEMARANG

Abstract

The Drug-Free Village program, known as "Desa Bersinar" in the City of Semarang, aims to combat drug abuse and promote a healthy, safe environment. This study evaluates the efficiency of the program's implementation by examining its planning, execution, and outcomes in reducing drug-related activities. Utilizing a mixed-method approach, data was collected from both quantitative surveys and qualitative interviews with village leaders, local government officials, and residents. The findings reveal that although the program has raised awareness and involved community participation, certain challenges such as lack of resources, insufficient coordination between agencies, and inadequate monitoring persist. These factors have impacted the overall efficiency and sustainability of the program. Furthermore, the study highlights the need for enhanced collaboration between local authorities and national drug enforcement bodies, as well as increased funding and training for community leaders. In conclusion, while Desa Bersinar has made significant strides in addressing drug issues in Semarang, more focused efforts are needed to improve its longterm effectiveness. Recommendations include reinforcing local support structures and creating better strategies for continuous monitoring and evaluation. This research contributes to the understanding of community-driven approaches in the fight against drug abuse at the village level.

RESULT DAN DISCUSSION

Fund Management Process

The process of managing funds in the Shining Village Program in Semarang City is a very crucial aspect in determining the overall success of the program. From the results of the research conducted, it can be concluded that the management of program funds has been running efficiently, although there are several challenges that need to be considered in the future. Efficiency in managing these funds is demonstrated through several main indicators such as timely allocation, use according to plan, and minimal reports regarding misuse of funds.

The following is a table of the fund management process with results reaching 70% of 100 respondents regarding the Efficiency of the Shining Village Program in Semarang City:

First, in terms of fund allocation, the majority of respondents, namely around 78%, reported that program funds were received according to a predetermined schedule. This is very important because delays in funding allocation can hamper the implementation of planned activities. The timeliness of this allocation shows that the government and related parties in managing the Bersinar Village Program funds have a fairly good system for managing the available budget. This system may involve strict mechanisms for submitting and verifying the funding needs of each village, as well as good coordination between the city government and village authorities to ensure that the funds allocated are in accordance with planned needs.

This condition indicates the need to increase capacity in financial management at the village level through more intensive training or mentoring.

First, in terms of reporting, the results of the study showed that most village officials and program coordinators felt that the reporting process had been running quite efficiently. Accurate and complete documentation not only serves as evidence of accountability, but also as useful program evaluation material for future improvements. In the Shining Village Program, documentation is carried out by recording each activity in detail, storing all relevant documents, such as work plans, progress reports, and proof of expenditure, and documenting the results of activities in the form of written reports, photos, and videos.

This study found that documentation had been carried out, there was heterogeneity in the quality and timeliness of documentation across villages. Some villages managed to document their activities very well, keep all records systematically, and ensure that each activity was properly monitored. However, in other villages, documentation was still done manually and did not always follow established guidelines. This raises problems in terms of data consistency and readability, which can affect the evaluation and decision-making process in the future(Imfyan & Amri, 2022).

To overcome these obstacles, the main recommendation from this study is to increase the capacity of village officials and program coordinators in terms of technical reporting and documentation. Special training needs to be provided to ensure that each village has the ability to prepare reports and do documentation according to established standards. In addition, the use of information technology such as simple but effective project management applications is expected to increase efficiency in reporting and documentation, as well as minimize errors and delays. This increased technological support will also help speed up the process of data collection and analysis, which is very important for assessing the overall success of the program.

Monitoring and Evaluation

Monitoring and evaluation are two key aspects in ensuring the success of a program, including the Shining Village Program in Semarang City. This program aims to improve the quality of life of village communities through various development initiatives, and monitoring and evaluation play an important role in ensuring that these goals are achieved effectively and efficiently. The monitoring process in the Shining Village Program in Semarang City has been carried out quite well, although there is room for improvement. Finally, although the frequency of evaluation is quite adequate, the depth of evaluation can still be improved, especially in terms of analyzing the long-term impact of the program on the community

DISCUSSION

The Shining Village Program in Semarang City is one of the government's initiatives aimed at improving the welfare of village communities through various development and empowerment activities. Efficiency in the implementation of this program is a very important aspect, considering the complexity of activities involving many parties, ranging from village officials, program coordinators, to local communities. In this context, efficiency covers various aspects, such as fund management, coordination between institutions, reporting and documentation, and program monitoring and evaluation(Siregar, 2022).

From the results of the research that has been conducted, it can be seen that the efficiency of the Shining Village Program in Semarang City can be said to be at a fairly good level. One of the most prominent aspects is the management of

program funds, where most respondents considered that the allocation and use of funds had been carried out according to plan and on time. This indicates good financial management, which is an important foundation in the implementation of a large-scale program like this. Efficient fund management allows every activity in the program to run smoothly without significant obstacles, and minimizes the risk of budget deviations.

However, even though fund management is running well, there are other challenges found in the aspect of coordination between institutions. Coordination between the village government, program coordinators, and local communities was considered quite effective, with most respondents stating that communication between the parties involved had gone well. However, there is still room for improvement, especially in terms of responding to problems that arise in the field. Often, problems that arise in the field require quick and appropriate resolution, and this is where efficient coordination becomes crucial. Failure to respond quickly can result in delays in the implementation of activities, which ultimately impacts the achievement of overall program objectives(Lestari, 2023).

Another important aspect of efficiency is reporting and documentation. The results of the study showed that reporting of activities and program documentation had been carried out quite well, with most respondents feeling that reporting was done on time and in accordance with established guidelines. However, respondents expressed delays in reporting, caused by technical factors and limited human resources. These delays in reporting can hamper the program evaluation process, so that necessary corrective steps may be delayed. Therefore, efforts need to be made to increase human resource capacity in this regard, as well as utilize information technology to facilitate the reporting and documentation process(Aneta & Mendo, 2022).

In addition, monitoring and evaluation are also important components of administrative efficiency. This study shows that monitoring of program implementation has been carried out quite well, with evaluations carried out periodically and the results used to improve the program. Good monitoring ensures that each stage of the program is running according to plan, and timely evaluations allow early identification of potential problems. However, there are suggestions to increase the frequency and depth of evaluations to ensure the overall effectiveness of the program. More in-depth and frequent evaluations will provide a clearer picture of program performance and allow for necessary adjustments to achieve the desired results. Overall, the discussion on the efficiency of the Shining Village Program in Semarang City shows that although the program has shown quite good performance, there are still several areas that need improvement. The main challenges that need to be addressed are limited human resources and the need to improve coordination and use of technology in reporting and documentation. By addressing these challenges, the efficiency of the Shining Village Program can be further improved, which in turn will increase the positive impact of the program on rural communities in Semarang City. Optimizing efficiency is very important to ensure that the main objectives of the Shining Village Program, namely empowering rural communities and improving welfare, can be achieved optimally(Silaban et al., 2023).

CONLUSION

This study concludes that the Shining Village Program in Semarang City has achieved a commendable level of efficiency, though certain aspects still need improvement. To enhance its efficiency further, several recommendations are proposed. These include boosting the capacity of human resources, better utilizing information technology to streamline the reporting process, and conducting more frequent and higher-quality evaluations of the program. By addressing these areas, the program can improve its overall effectiveness and continue to contribute positively to the community's development in a more efficient and impactful manner.
