Films play an important role in detailing the complex aspects of sexual violence. In this medium, characters, settings and conflicts related to acts of sexual violence can be depicted in detail so that viewers can think about the psychological and social implications related to this issue. So films can be a way to create empathy and a deeper understanding of the experiences of victims. These films open the door to understanding how visual media can overcome discrimination, gender inequality and cultures of violence. Films are a powerful way to represent the experiences of victims and increase public awareness of issues related to sexual violence. As a unique form of artistic expression, film can also be an important means for exploring and understanding issues of gender, sexuality and power in a society in the context of sexual violence. The film that the researcher analyzes is Promising Young Woman, an Americanproduced film that was first released on January 25 2020 at the Sundance Film Festival. This film is the debut of actress Emerald Fannell as a director and scriptwriter. The film Promising Young Woman stars Carey Mulligan, Bo Burnham, Alison Brie, Clancy Brown, Jennifer Coolidge,Laverne Cox, Chris Lowell, and Connie Britton.

Film Promising Young Woman wins many Hollywood Critics Association (HCA) awards. In addition to taking home the top prize, HCA awarded Carey Mulligan for her performance as the revenge-driven Cassie and director Emerald Fennell for her screenplay. Other winnersincluded Delroy Lindo for Best Actor in Da 5 Bloods and Yuh-Jung Youn who won Best Supporting Actress for Minari.

Women experience various types of harassment and violence. one example is sexual assaultor rape. especially when we are under the influence of alcohol. The influence of alcohol cantrigger calm in the heart and mind. This is one of the weak points that a woman faces when walking alone, especially in the middle of the night. Circumstances like this are what provoke men to commit sexual violence. Media representations of a woman who drinks alcohol are seen as being more easily seduced, and willing to have sex than those who don'tdrink alcohol. Alcohol is thought to provide comfort in situations that would normally be considered dangerous. The effects of alcohol on motor skills may limit a woman's ability to resist an abuser effectively, whereas sober ones are better able to resist effectively. Many men find it

more effective to seduce drunk women, so they try to get the victim drunk to get sex (Abbey 2002, 123).

The Film Promising Young Woman" is an interesting cinematic work that raises themes of justice and revenge. This film, which lasts 1 hour 53 minutes, tells the story of a woman named Cassie who tries to take revenge for sexual harassment committed by a number of men against her best friend named Nina. Cassie had to be willing to give up her dream of becoming a doctor and leave college. Cassie even gave up her time to often go to a club with selfmotivation to take revenge on the predatory men there. The purpose of this research is to explore how the themes of justice and revenge are presented in the film Promising Young Woman

However, in the process, she discovered that the existing justice system did not always prioritize justice and often tended to provide support to perpetrators of crimes. Therefore, this research will explore the themes of justice and revenge in the film Promising Young Woman. Focusing on the depiction of the issues of justice and revenge in this film, the aim of this research is to gain an understanding of how the film depicts these two issues and their impact on society's views on these issues. Previously, there have been many studies discussing the themes of justice and revenge in films. For example, Research Wregas Bhanuteja, director of the film "The Copy of Light", conducted research for one year by listening to stories from survivors of sexual violence cases and following news reports about similar issues to produce a film that voices the issue of sexual violence and the victims' struggle to obtain justice. Apart from that, there is also research by A. M. K. Kline in 2016 showing that films that display themes of justice and revenge can influence the emotions and behavior of the audience. To gain a deeper understanding of this topic, this research will involve a review of relevant previous literature. The literature review will include theories about justice and revenge in the context of films, as well as analysis of similar films that have existed before. By conducting a previous literature review, this research is expected to provide deeper knowledge and understanding of how the film Promising Young Woman depicts the concepts of justice and revenge." The novelty of this research lies in the in-depth analysis of the film Promising Young Woman which has not been studied much before. In this research, researcher will carry out an analysis character conveyed in this film. Thus, this research is expected to provide new insights and a deeper understanding of how the film Promising Young Woman depicts the concepts of justice and revenge. and through this research the researcher hopes to find answers to important questions regarding how this film can be a strong representation of women's struggle to seek justice and revenge for the events they experience.

METHODS

In this research, researcher used qualitative research with a content analysis approach. Qualitative research methods were used because this research aims to make it easier to understand the themes of justice and revenge in the film Promising Young Woman. The data source used in this research are premiere data from the film Promising Young Woman itself. Researcher will analyze this film in depth to identify scenes, dialogue, characters and messages related to the concepts of justice and revenge. This data source is used to gain an indepth understanding of how the themes of justice and revenge are presented in the film and their impact on the audience. and the data collection method used in this research is observation and film analysis techniques. this technique is used to observe and record scenes, dialogue and actions that occur in the film.

The data analysis used by researcher in conducting this research was by analyzing narratives and identifying themes related to justice and revenge. Then the data collected will be analyzed using qualitative analysis with the aim of identifying narrative patterns and messages contained in the film Promising Young Woman. By using this method, this research is expected to provide in-depth insight into how the film Promising Young Woman depicts the concepts of justice and revenge. This research method also allows researcher to

comprehensively analyze elements related to the research topic, so as to provide broader and deeper insight into this film.

FINDING AND DISCUSSION

After completing the analysis, the researcher found evidence concerning Cassie's characterization using a feminism approach. This research focuses on examining Cassie's actions that rely on radical feminism. Characterization in a literary work is very important because each protagonist and antagonist has a unique character. In this article it is necessary to find out the reasons for the emergence of radical actions in the main character in the film Promising Young Woman.

This research will take the point of view of existing feminist theories. Currently, feminist theories include Liberal Feminism, Radical Feminism, Marxist-Socialist Feminism, Gender Psychoanalytic Feminism, Existentialist Feminism, Postmodern Feminism, Multicultural and Global Feminism, and Ecofeminism. However, this study will specifically focus on Radical Feminism. The researcher will also discuss the goals behind Radical Feminism to further detail the issues addressed by this perspective.

Ti-Grace Atkinson in her basic work, "Radical Feminism" (1969) stated that "Radical feminism is a movement to liberate women from oppression by men. This is an effort to liberate women from sexual slavery, from gender roles, and from domestic roles. that has been established by patriarchal society. a. Justice cannot always be achieved through the legal system:

This film shows how the justice system often fails to provide justice to victims of sexual violence. This is also reflected in the main character. Cassie, who felt that the legal system was unable to provide justice for her friend who was a victim of sexual violence. That's why she decided to take action herself so that the perpetrator of sexual violence received the appropriate punishment.

At the beginning of the film it also shows that Cassie also became a victim of sexual harassment when she was reprimanded by a number of construction workers. As we know, almost 84% of women often face catcalling. Research results show that catcalling is a form of verbal sexual harassment and has a negative impact on the victim's life. The informant who was the victim of catcalling chose to remain silent even though it had a deep impact, even leading to traumatic experiences. But it was different from Cassie when she received treatment like that. Instead he stared sharply back at the person who called him.

Macmillan et al (2000) argue that one of the effects that occurs as a result of catcalling includes limiting a person's freedom to move. Catcalling creates fear in victims and makes them feel that they have to be alert when they are out and about. Melsen (2004) said that catcalling is done to cause fear and dominate the victim (Ellaine, 2018).

In this scene, Cassie tries to seek justice and rights for her late friend. However, by using very extreme and dangerous methods, this may not even be easy for women to do in real life.

Through we can see through the color code on the pen which shows that Cassie has had many victims to take revenge on the predatory man. However, it seems that there are still blank sheets left, which means that Cassie is still not satisfied with eliminating predators who abuse or treat women with disrespect and Cassie will not stop filling in the blank sheets before she finds out who is the main mastermind behind the murder of her best friend. However, on the other hand, Cassie's actions are very dangerous and very risky if practiced for women. Cassie's strategy to stop objectification is seen as radical. even the type of feminist who in general would never think of putting herself in danger just to gain rightsby letting her body be played with by men. In situations like this, it is very natural that women prefer to avoid being used as sexual objects by men "Studies have shown that individuals often underestimate their own risk of being attacked compared to the average person of their gender. This tendency to downplay personal vulnerability, whether the aggressor is an acquaintance or a stranger, reflects a belief system that may be influenced by various socio-cultural factors" (Smith et al., 2005).

In contrast to other women, Cassie, who is considered a radical feminist, chooses to ignore this advice. what Cassie did was the idea of putting herself in a bad and risky situation. However, on the other hand, Cassie has awakened a strong and bravefeminist spirit to fight alone and never give up for the feminist rights that women have. So the theme of this film is about Cassie's best friend, Nina, who was raped by Al-Monroe. In this film, Nina, who is under the influence of alcohol, makes Al Monroe take advantage of Nina by having sexual relations with her. But unfortunately, no one believed Nina that Al Monroe was the one who sexually harassed her. As a result, Nina experienced depression and very deep regret. Such an experience will definitely traumatize us deeply and will also affect our future.

In this scene, Cassie and Nina's friend provide a videotape showing Nina being raped by Al-Monroe. The recording is clear evidence that Nina has become a sexual object that is viewed by other people. This picture shows the disturbing part. the camera position focuses on Cassie's facial expressions. despite the fact that the public ignored the disclosure of the video. in this scene shows Cassie's frightened eyes when she watches the video recording of her friend being unconscious when her friend was sexually assaulted. The evidence that Cassie saw caused her mental and emotional disturbances. Cassie's parents also think that their child's behavior often looks like depression and isolation, which causes Cassie to spend her time planning radical feminist ideas to take revenge for the sexual harassment behavior experienced by her best friend Nina.

2. Aggressive Tendencies

After the death of her best friend Nina, Cassie begins to associate feelings of contentment with revenge and violence, as her aggressive behavior. However, this actually leads him to a strange habit, this is a self-destructive behavior. One of her behaviors that tends to be aggressive, Cassie's strange habits include verbal hostility, namely causing fear in every lecherous man who tries to rape her while 'pretending' to be drunk. This is aggressive because it involves enjoying other people's suffering. However,she considers that what they are trying to do to him is wrong, as can be seen in the text below.

Neil :. Alright. Fuck. I take your point. What do you want from me? To say I'm an asshole? Fine, I'm an asshole.

Cassie : Why are you so freaked out, Neil? Wow. You really need to calm down. At least you didn't try to have sex with me while I was passed out. You do get points for that. I want you to be proud of yourself. A few guys...eh they don't mind so much. But you, you woke me up before putting your fingers inside me. That was sweet.

The desire for revenge reappears when Cassie gets news from Ryan Cooper that Al Monroe has just returned after 10 years in England. and will have a bachelor party. Hearing this news, Cassie felt uncomfortable, as can be seen in the picture 1 above, which was taken using a medium close-up shot. Here, her ego fails to withstand the demands of her destructive identity so she decides to harm the people responsible for Nina's death. Taking revenge against those people brings a sense of satisfaction to Cassie. The use of a medium shot in the picture 2 above depicts Cassie's expression which looks satisfied when she sees Dean Walker desperately apologizing.

To get revenge against Al Monroe, Cassie plans to attend a bachelor party hosted by Al Monroe as a stripper. While at the party, Cassie was so passionate about killing Al Monroe that she tried to write Nina Fisher's name all over Al Monroe's body using a sharp tool, as a reminder of Al Monroe's relationship with Nina.

Can true resolution be achieved through acts of retaliation, or does it require a more profound journey of self-discovery and acceptance? As Cassie grapples with these existential quandaries, audiences are drawn into a dizzying whirlpool of moral uncertainty, forced to confront their own assumptions and biases. In the end, "Promising Young Woman" transcends the confines of traditional cinematic storytelling, emerging as a provocative meditation on the nature of morality, agency, and the eternal quest for meaning in a world fraught with ambiguity. Through its intricate narrative and morally complex characters, the film challenges us to confront the inherent messiness of life and the impossibility of easy answers. In doing so, it offers a profound reflection on the human condition and the eternal struggle to navigate the treacherous waters of moral ambiguity with grace and integrity.

d. Patriarchy

According to radical feminist experts, patriarchy in society is considered a system of sexual hierarchy that prioritizes male power. They argue that this patriarchy causes the oppression of women through various means, such as physical exploitation, racism, heterosexuality, and marginalization. Radical feminists reject the institution of the family as a source of suffering for women, because it is considered a place where women are exploited biologically and socially. In Promising Young Woman (2020), patriarchal society is seen in the university dean, students, and even the legal system who do not take the sexual violence case experienced by Nina seriously.

The first person discussed is Dean Walker of Forrest University. Cassie meets him to pretend to continue her medical studies. When they accidentally meet, Cassie is only there to bring up Nina's case, Dean Walker doesn't remember who Nina is. However, the dean can only remember Al Monroe, the perpetrator, as a kind and intelligent person. Cassie discussed Nina's case which Dean Walker had previously handled. Dean Walker, like Maddison, doesn't believe Nina's side of the story. There was no defense support given to Nina, who instead received a rejection of the accusations made by Dean Walker's best student at the time, Al Monroe. The following conversation shows how Cassie fought to get justice for Nina.

Cassie : "You felt that there wasn't sufficient evidence. You said there's too much of a 'He said',

'She said' situation"

Dean : "We get accusation like this all the time. One or two a week,"

Dean : "What would you have me do? Ruining a young man's life every time we get an accusation

like this?'

Cassie : "So you're happy to take the boy's word for it?"

Dean : "I have to give him the benefit of the doubt. Because innocent until proven guilty"

The dean's response made Cassie even more convinced that there was gender bias against Al Monroe, a male medical student who had a reputation for being kind to others both inside and outside the university. In addition, she is a smart and excellent student, making it difficult for other people to believe Nina's case. while Nina is an ordinary medical student on campus who, because of her gender identity, has been stereotyped at every corner, with people always thinking that the woman is a seductress of men and that the "guilt of rape" is the reward she gets for being a flirtatious woman . Patriarchy does exist in this toxic system. In the setting of this film, where men dominate the social hierarchy, their opinions take priority. Therefore, those in authority tend to silence women's opinions. Even so, the stereotype that exists towards Nina is not true.

In the film Promising Young Woman, the person involved in Nina's rape case is Mr. Green, Al Monroe's lawyer in the rape case. In order to achieve success as a lawyer, Mr. Green once threatened and bullied Nina in court until Nina was forced to drop the charges against Al. Due to the higher socioeconomic status of men, Mr. Green was blinded by power and money at the time, so he did whatever he could to ensure that Al Monroe won and went unpunished. This shocked Cassie because she had an idea that he was a misogynistic man who had ruined a woman's life. power is related to privilege. In a system where men have more power than women, men have a certain level of privilege that women do not have."

The reason behind his change in behavior was because Mr. Green had an epiphany that made him regret his actions towards his opponents who he had wronged, including Nina. Mr Green even resigned himself to accepting the offer to be hurt because he felt he deserved it. Cassie also initially prepared a hitman to torture Mr. Green

In this story, Mr Green is the person Cassie hates the most in this case because he prevents Nina from receiving fair treatment and winning her case in court. That's why he took various kinds of revenge on the people who had ruined Nina's life. He almost got the worst revenge by being tortured by an assassin. Fortunately, there is a deep sense of regret in Mr. Green, even though she has a feminist nature, she still feels sorry for Mr. Green because he still has moral values. Loyalty to his friend is still prominent, but pity trumps loyalty. Therefore, Cassie took back the hitman's idea and instead forgave him because she felt that Mr. Green changed. At the end of the story, Cassie is able to destroy the patriarchal system in this film and destroy Al Monroe's domination of power.

e. Reflection On The Impact Of Revenge In Society

Apart from justice, the film Promising Young Woman also explores the concept of revenge. Cassie uses revenge as a form of expression of justice desired by victims of sexual crimes. However, Cassie plans and carries out revenge very strategically. Revenge is a behavior that is widespread and often appears in the form of aggression or conflict. The desire for revenge can motivate someone to kill, hurt others and even cause international conflicts (McCullaugh, 2008). However, this film also invites viewers to question the effectiveness and morality of revenge as a form of justice. The results that can be explored in this film are the impact of the acts of revenge depicted in the film Promising Young Woman in this film researchers can analyze about how acts of revenge can affect individuals in society more broadly. This film discusses how revenge can bring justice or only make the situation worse, as well as its impact on the victim, perpetrator or society as a whole. This research also involves considerations of ethics and morality in the context of revenge. Someone can carry out revenge for various reasons and the reason that drives someone to do this is because they want to get emotional satisfaction. Revenge provides emotional satisfaction for someone who feels hurt or wronged, so with revenge they may hope to eliminate the feelings of anger, sadness or justice they feel.

Geoff Beattie (2022), a psychology professor from England, argues that people who have been hurt or betrayed seem to really believe that if the other party suffers, they will feel better and the emotional pain will be reduced. In fact, after an act of revenge, this may not necessarily happen. In a 2008 study, researchers found that people often report significantly more negative moods immediately after carrying out acts of revenge.

The conclusion is that avengers report a mix of emotions. Revenge "is not always sweet, but has bitterness." This means that revenge actually has the capacity to trigger both positive and negative emotions (including feelings of tension, uncertainty, and fear). Cassie, as the main character in this film, also shows that she took revenge to seize the rights to the sexual harassment experienced by her friend Nina and also as an effort to change society's view of victims of sexual crimes. Cassie does not use physical violence in her actions, but uses clever strategies and relies on her intelligence and emotional strength. while these actions may feel personally satisfying, the film illustrates that revenge can lead to ongoing problems. Cassie's act of revenge will create a cycle of violence that is difficult to stop.

In addition, revenge can also lead to loss of self-direction and destructive obsessions. Cassie becomes obsessed with revenge, which causes her to become socially isolated and lose contact with the people around her. This shows that acts of revenge can destroy an individual's life and affect a person's mental health. This film depicts that revenge will cause negative attitudes and hatred. Apart from that, revenge can also encourage physical or emotional violence. as in this film, it is seen that Cassie uses dangerous and self-defeating revenge tricks that can trigger further acts of violence.

in the last scene in this film, Cassie has to accept all the consequences of the revenge she took against Al Monroe. Cassie herself was killed at the hands of Al Monroe when she tried to take revenge on Al Monroe, but Cassie actually already knew that she would die at the hands of Al Monroe, but He thought that that way it would be easier for Al Monroe to prosecute Al for murder rather than rape. Therefore, Al Monroe was arrested by the police and he was successfully put in prison. what Cassie has done by giving her life to restore justice for her friend Nina is a very feminist and radical person because Cassie had to give up her life as evidence of crimes committed by men against women. She succeeded in using this method but it is not natural to imitate it. by women.

CONCLUSION

The research conclusions in the film Promising Young Woman reveal that Cassie's actions rely on a radical feminism system. This research also discusses the goals behind radical feminism which aims to liberate women from male oppression, sexual slavery and gender roles. Apart from that, this research also focuses on that justice cannot always be achieved through the legal system, as in this film where the justice system often fails to provide justice to victims of sexual violence. and this film also explores the concept of revenge showing that how acts of revenge can affect individuals in society as well as its impact on victims, perpetrators and society as a whole. This research provides a deep understanding of the complexity of Cassie's character and the use of radical feminism as a tool to combat oppression against women. Apart from that, this film also depicts how justice is often not achieved through the legal system, which reflects failure in handling sexual harassment cases. Additionally, this research also reveals the impact of revenge in society, highlighting that acts of revenge can bring justice or simply worsen the situation, as well as its impact on individuals and society as a whole. In conclusion, this research provides in-depth insight into the important themes raised in the film Promising Young Woman, including radical feminism, the failure of the legal system in handling cases of sexual harassment, and the impact of revenge in society. The film provides a powerful depiction of the complexity of these issues and raises deep questions about justice, feminism, and morality.
